Explanation:

1. Application for value-added use: the government institution and organization may fill out and submit the completed application form for value-added use together with the completed and signed control consent form of value-added use to apply for the authorized value-added use of electronic files of land section data, Taiwan Electronic Maps data, land use investigation data or basic topographic map data.
2. Application for update: an applicant who has applied for computerized surveying and mapping results may apply for update of available data by submitting the completed application form together with other relevant supporting documents in person, by fax or post.
3. An applicant for value-added use may fill out and submit the completed application form for value-added use together with relevant supporting documents to apply for update or addition to the authorized use.
4. An applicant whose application for none value-added use has been completed may apply for the change of none value-added use to authorized value-added within six months. The permitted applicants and methods of application for such change are the same as the requirements for application for value-added use.
